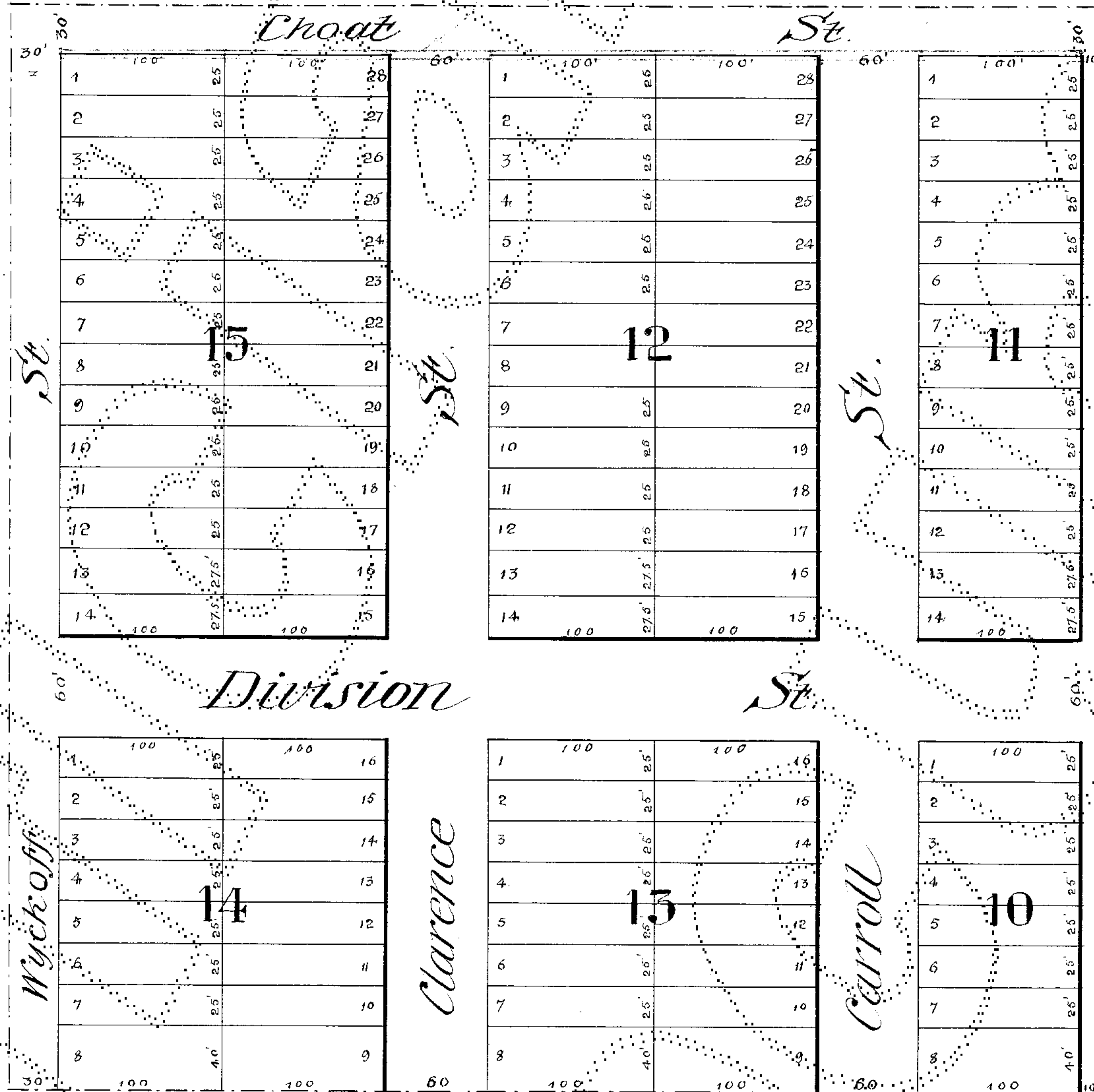


Plat of Randell's 2nd Addition To the City of Seattle.

DESCRIPTION.

This Addition embraces tracts 85 and 88 of the "Seattle Homestead Association 5 acre tracts", further described, as follows:

Beginning at a point 660 ft. north of the $\frac{1}{4}$ Sect. cor. on the east line of Sect. 33, Twp. 25 N. R. 4 E. N. M.

Thence North, 660 ft. - thence East 660 ft. - thence South 660 ft. - thence West 660 ft. to place of beginning.

The S.W. cor. of lot "B" blk. "14" is 30 ft. east and 660 ft. north of the $\frac{1}{4}$ Sect. cor. on the east line of Section 33. -

All Bearings are referred to said Sect. line which is considered a true Meridian.

Lots are 25 x 100 ft. or as indicated on plat. - Streets 60 ft. or as shown on plat.

DEDICATION.

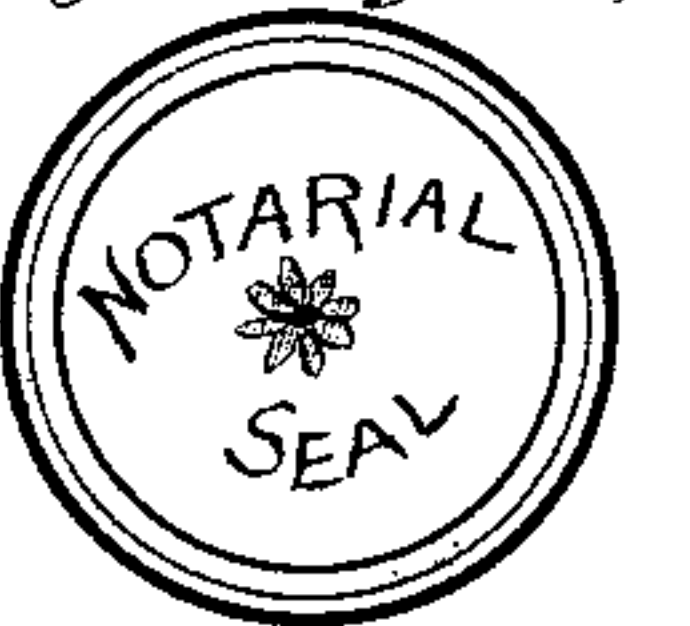
